ADMINISTRATIVE ORDER
No. 2010-0061

WHEREAS: The Arizona Code of Judicial Administration section 1-302 specifies training requirements for judicial and court employees in the State of Arizona; and

WHEREAS: Arizona Supreme Court Administrative Order 2009-88 specifies that “the continuing judicial education and training requirements established in the Arizona Code of Judicial Administration (ACJA) Section 1-302 for all employees in the Judicial Branch, except judicial officers, are reduced by fifty percent to 8 hours, and the core curricula requirements provided by ACJA Section 1-302.K.2 are suspended for calendar year 2010.”; and


WHEREAS: There will be no statewide Judicial Conference sponsored by the Arizona Supreme Court for calendar year 2010;

NOW, THEREFORE, IT IS HEREBY ORDERED:

1. In order to ensure that Pinal County Judicial Branch employees, other than judicial officers, obtain the required 8 hours of COJET approved training, including ethics, Pinal County will hold its local COJET training on June 9 – 11, 2010.
2. In order to allow for the local COJET training, the Superior Court of Arizona in and for the County of Pinal and all Justice Courts in Pinal County shall only conduct emergency hearings, mandated hearings, and statutorily required functions during the period of June 9 – 11, 2010.
3. All Judicial Branch employees in Pinal County shall attend the local COJET training, unless the mandatory hours are already satisfied.
4. Judges in Pinal County may attend the Bar Association Conference, June 9 -11, 2010, to obtain the required 16 hours of COJET approved training, including ethics, unless mandatory hours are otherwise satisfied.

5. All Judicial Branch employees shall submit documentation of attendance at any COJET approved training to their assigned COJET Training Coordinator upon completion of the training, and no later than July 30, 2010, pursuant to Administrative Order No. 2008-16.
