ADMINISTRATIVE ORDER

WHEREAS the Presiding Judge has administrative oversight of the Judicial Branch of government in Pinal County, and certain caseloads must be reassigned due to the retirement of two Superior Court Judges and the resignation of a full time Commissioner,

NOW, THEREFORE,


IT IS HEREBY ORDERED that all pending Criminal Cases (CR files) that are currently assigned to the Hon. Janna Vanderpool or her successor in office, as well as all future calendar dates in these same cases that are currently scheduled before the Hon. Boyd T. Johnson, are hereby permanently reassigned and reset before the Hon. Bradley Soos, Judge *Pro Tempore*, effective July 1, 2013. The scheduled Law & Motion calendars for this caseload shall remain unchanged until further administrative order, and this caseload shall continue to receive its regular share of new cases, assigned to Judge Soos.

IT IS FURTHER ORDERED that all pending Criminal Cases (CR files) that are currently assigned to the Hon. Boyd T. Johnson shall remain assigned to "Judge Johnson or his successor in office", and future hearings in these cases shall be set before "Judge Johnson or his successor in office". Judges of this court shall cover this caseload as may be directed from time to time by the Presiding Judge, until further administrative order. The scheduled Law & Motion calendars for this caseload shall remain unchanged until further administrative order, and this caseload shall continue to receive its regular share of new cases, assigned to "Judge Johnson or his successor in office".

IT IS FURTHER ORDERED that all pending cases of any type that are currently assigned to Commissioner Theresa Ratliff, as well as all future calendar dates in any cases that are scheduled before Commissioner Theresa Ratliff, are hereby permanently reassigned and reset before the Hon. Bradley Soos, Judge *Pro Tempore*, effective July 1, 2013. The scheduled Law & Motion calendars for this caseload shall remain unchanged until further administrative order, and this caseload shall continue to receive its regular share of new cases, assigned to Judge Soos.

Further reassignments of caseloads will occur as Commissioners' assignments rotate and as successor judicial officers are appointed. The Court's objectives are to reassign as few cases as possible and make every effort that no case will be reassigned more than once.
