IT IS HEREBY ORDERED, that **CODY WEAGANT** be and he is hereby appointed to serve as Justices of the Peace *Pro Tempore* for a period commencing July 27, 2015 and ending December 31, 2015.

IT IS FURTHER ORDERED that **CODY WEAGANT** be compensated in accordance with state law; payable through funds budgeted in the Judicial Branch and/or the Justices of the Peace for such purposes.

This appointment is at the pleasure and direction of the Presiding Judge of the Superior Court. Such appointment may be terminated without cause at any time by the Presiding Judge.
