ADMINISTRATIVE ORDER

No. 2015 - 00049

**WHEREAS** the Presiding Judge of the Superior Court of Arizona in and for Pinal County is the Chief judicial officer of the county and has administrative authority over all courts in Pinal County, pursuant to Article VI of the Arizona Constitution and Arizona Supreme Court Administrative Order No. 2005-32 (revised May 16, 2005); and

**WHEREAS** the Superior Court is modifying certain caseload management practices based on the appointment of a new Commissioner/Judge Pro-tem.

**NOW, THEREFORE, IT IS ORDERED** affirming all current duties and assignments of all full-time and part-time judicial officers of the Superior Court, except where modified by this Administrative Order, effective September 14, 2015.

**IT IS FURTHER ORDERED** appointing DeLana J. Fuller (DJF) as a full-time Superior Court Commissioner/Judge Pro-tempore for Pinal County commencing September 14, 2015 and ending June 30, 2016, subject to annual reappointment by the Presiding Judge, pursuant to Section 12-211 of the Arizona Revised Statutes. The Commissioner/Judge Pro-tempore shall serve at the direction and pleasure of the Presiding Judge of Pinal County.

**FAMILY**

**IT IS ORDERED** that Judge Karl C. Eppich (KCE) shall continue to be assigned to the Family Bench.

**IT IS FURTHER ORDERED** that Judge Pro Tem Bradley M. Soos (BMS) shall continue to be assigned to the Family Bench and shall be directly supervised by the Presiding Family Law Judge, except that the Presiding Judge shall continue to assign temporary court-calendar coverage duties, as required.

**IT IS FURTHER ORDERED** that all Family Law or Domestic Relations cases (identified by the prefix DO), currently assigned to the Hon. Karen J. Stilwell, shall be assigned to the Hon. DeLana Jacobs Fuller (DJF),

**IT IS FURTHER ORDERED** that all new Family Law or Domestic Relations cases (identified by the prefix DO), shall be assigned to the Hon. DeLana Jacobs Fuller (DJF), Hon. Delia R. Neal (DRN), and Hon. Karl C. Eppich (KCE) as determined by the two terminal digits of each Domestic Relations file as follows:
