ADMINISTRATIVE ORDER

No. 2016-00 11

**Whereas** the Presiding Judge has general administrative authority over the Judicial Branch of government in Pinal County;

**Whereas** the Presiding Judge previously adopted Administrative Order 2016-0007, *Establishment of Modified Policies and Procedures for Court-Appointed Counsel and Providers of Related Services*, which requires the appointment of a *Selection Committee* and a *Billing Special Master* to implement said policies and procedures;

**Whereas** the Pinal County Manager is an ex officio member of the *Selection Committee* but has requested approval by the Presiding Judge of Assistant Pinal County Manager Leo Lew as the Pinal County Manager's standing proxy;

**Whereas** members of the *Selection Committee* serve at the pleasure of the Presiding Judge with staggered two year terms, but the Presiding Judge may appoint members for less than two years in order to establish staggered terms; and,

**Whereas** the Presiding Judge is a non-voting chair of the *Selection Committee*, except to break a tie if a voting member is absent or recuses;

**Now, therefore,**

**IT IS HEREBY ORDERED** appointing the following persons to serve as voting members of the *Selection Committee*, pursuant to § 1.3.1, Administrative Order 2016-0007, who shall serve at the pleasure of the Presiding Judge, subject to reappointment following expiration of any term of service:

1. Hon. Boyd T. Johnson (Ret.), a former judicial officer of the Pinal County Superior Court, expiring December 31, 2017;
2. Mr. Leo Lew, as standing proxy for the Pinal County Manager, expiring December 31, 2016;
3. Mr. David A. Fitzgibbons III, as an at-large member, expiring December 31, 2016.

**IT IS FURTHER ORDERED** appointing the Hon. Robert Carter Olson as the *Billing Special Master*, pursuant to § 1.4, Administrative Order 2016-0007, who shall serve in this capacity at the pleasure of the Presiding Judge and shall receive no additional compensation for this assignment.
