ADMINISTRATIVE ORDER

WHEREAS, the Criminal Justice Coordinating Committee (CJCC) is a partnership between county and state criminal justice agencies and departments to address issues and needs arising within the justice system in Pinal County;

WHEREAS, it is recognized that collaboration and coordination with all criminal justice stakeholders is necessary for true system improvement. The CJCC is dedicated to working together to continually improve the administration of justice in Pinal County and will serve as a forum for identifying issues and their solutions, proposing actions and facilitating cooperation that will improve public safety and the related criminal/juvenile justice services in Pinal County;

WHEREAS, it is recognized that the efficient and effective management of the jury system facilitates informed decision-making by trial jurors and increases public trust and confidence in the jury system and in courts;

WHEREAS, it is also recognized that effective management of court scheduling impacts jury management; and

WHEREAS, adopting best practices and implementing innovative approaches that both improve the juror experience and contribute to better court management strengthens the jury system;

NOW, THEREFORE, IT IS ORDERED that the Jury Trial Improvement Advisory Subcommittee be created to meet these needs and the persons listed in Appendix A are hereby appointed to this committee.
