The presiding judge of the Superior Court of Arizona in Pinal County has requested the appointment of a court commissioner to serve as a judge pro tempore to assist that court with the processing of cases. Therefore, pursuant to Ariz. Const. Art. VI, § 31 and A.R.S. § 12-141 et seq.,

IT IS ORDERED that Megan K. Weagant, State Bar #027244, is appointed judge pro tempore to serve the Superior Court in Pinal County for a term beginning January 3, 2017, and ending June 30, 2017.

IT IS FURTHER ORDERED that the appointee shall perform judicial duties authorized by A.R.S. § 12-144 as assigned by the presiding judge.
