Her powers as a Special Commissioner are limited to considering and determining applications filed pursuant to A.R.S. § 12-302 requesting deferral of filing fees, service of process fees and other fees pursuant to A.R.S. §12-284 and signing an Order for Deferral and Order to Appear on request to Establish and Enforce Child Support and other orders.

IT IS FURTHER ORDERED that this assignment is conditioned upon the agreement by **Maria Gutierrez** to serve as a Special Commissioner for this designated matter only and to do so for no additional compensation or benefits, fiscal or otherwise.


