ADMINISTRATIVE ORDER

**WHEREAS**, the Presiding Judge of the Superior Court of Arizona in and for Pinal County is the Chief Judicial Executive Officer of the County and has administrative supervision over all courts in Pinal County pursuant to Article VI of the Arizona Constitution and Arizona Supreme Court Administrative Order No. 2017-79; and

**WHEREAS**, the Presiding Judge seeks to align the Court with the Chief Justice's "Advancing Justice Together" Strategic Plan as it relates to promoting access to justice and improving court processes and procedures to better serve the public; and

**WHEREAS**, the Court's vision is to further enhance administrative integration and efficient operation of the Judicial Branch in Pinal County through the use and expansion of Information Technology, staff resources and services to the Superior Court, Clerk of Superior Court, Adult Probation, Juvenile Court Services, Conciliation Court Services, and Limited Jurisdiction Courts to better serve the citizens of Pinal County; and

**WHEREAS**, the Presiding Judge has determined that further assessment of Information Technology and resources is required to determine what is necessary, appropriate and in the best interests of the Judicial Branch to provide efficient delivery of court services in Pinal County;


**IT IS HEREBY ORDERED**, that the Committee on Information Technology and Resources in the Pinal County Superior Court is established as follows:

1. **Purpose.** The Committee shall review and, as appropriate, develop recommendations on:
  - a. Current information technology utilization and costs;
  - b. Complete an information technology gap analysis;
  - c. Options for enhancing the availability and use of information technology resources in the courts.



2. **Membership.** The individuals listed in Appendix A are appointed as members of the Committee beginning upon entry of this Order. The Presiding Judge may appoint additional members as may be necessary.
3. **Meetings.** Committee meetings shall be scheduled at the discretion of the Chair.
4. **Staff.** Pinal County Court Administration shall provide staff for the Committee and shall assist in developing recommendations.
5. **Recommendations.** Recommendations shall be submitted to the Presiding Judge for review.
