ADMINISTRATIVE ORDER

WHEREAS, the Presiding Judge of the Superior Court of Arizona in and for Pinal County is the Chief Judicial Executive Officer of the County and exercises administrative supervision over justice of the peace courts in Pinal County pursuant to Article VI of the Arizona Constitution and Arizona Supreme Court Administrative Order No. 2017-79; and

WHEREAS, on July 12, 2017, pursuant to A.R.S. §2201(A), the Pinal County Board of Supervisors signed Resolution No. 071217-JPB initiating a redistricting of the Pinal County justice precincts to be effective on January 1, 2019; and

WHEREAS, the Court's vision is to enhance the integration and efficient operation of the justice courts in Pinal County to better serve the citizens of Pinal County; and


WHEREAS, the Presiding Judge seeks to help facilitate a comprehensive and orderly realignment of the justice of the peace courts in Pinal County;

IT IS HEREBY ORDERED, that the Committee on Justice Precinct Redistricting is established as follows:

1. **Purpose.** The Committee shall review and consider the following areas in addition to topics and/or issues as deemed appropriate by the Chair:
 - a. Facility needs and/or improvements;
 - b. Coordination of all judicial administrative issues;
 - c. Coordination of all staffing and human resources issues.
2. **Membership.** The individuals listed in Appendix A are appointed as members of the Committee beginning upon entry of this Order. The Presiding Judge may appoint additional members as may be necessary.
3. **Meetings.** Committee meetings shall be scheduled at the discretion of the Chair.
4. **Staff.** Pinal County Superior Court Administration shall provide staff for the Committee.

5. Recommendations. Recommendations shall be forwarded to the County Manager and/or the Presiding Judge as appropriate.
