AMENDED
ADMINISTRATIVE ORDER

No. 2018 - 06

WHEREAS the Presiding Judge of the Superior Court of Arizona in and for Pinal County is the Chief judicial officer of the county and has administrative authority over all courts in Pinal County, pursuant to Article VI of the Arizona Constitution and Arizona Supreme Court Administrative Order No. 2017-79; and

WHEREAS the Honorable Karl Eppich has been appointed to the Court of Appeals, Division II, which required the reassignment of his caseload, and, the Honorable Christopher J. O'Neil has been appointed to the Pinal County Superior Court bench, modification of the current allocation of resources is necessary;

NOW, THEREFORE, IT IS ORDERED affirming all current duties and assignments of all full-time and part-time judicial officers of the Superior Court, except where modified by this Administrative Order, effective January 26, 2018.

CRIMINAL

IT IS ORDERED that all new Criminal files (identified by the prefix CR), except for those matters assigned to specialty courts, such as "Early Disposition Court", shall be assigned to the Hon. Steven J. Fuller (SJF), Hon. Jason R. Holmberg (JRH), Hon. Christopher J. O'Neil (CJO), and Hon. Lawrence Wharton (LMW), as periodically determined by separate Order of the Presiding Criminal Judge.

IT IS FURTHER ORDERED that the Presiding Criminal Judge shall direct the reassignment of the current Criminal cases of Judge Kevin D. White, that were filed on or after March 1, 2017 and are not currently set for trial before March 31, 2018, to Judge Christopher J. O'Neil (CJO), considering potential conflicts. The Presiding Criminal Judge shall also direct the reassignment of the current Criminal cases of Judge Kevin D. White (KDW), that were filed before March 1, 2017, and are not currently set for trial before March 31, 2018 to either Judge Steven J. Fuller (SJF) or Judge Christopher J.

O'Neil (CJO), considering potential conflicts, except those cases that Judge Kevin D. White determines that he should complete. These matters should be reassigned as soon as practical, by whatever method deemed most appropriate by the Presiding Criminal Judge, but case transfer shall be completed no later than February 28, 2018, and thereafter on a case-by-case basis by the Presiding Criminal Judge.

IT IS FURTHER ORDERED that all ex-parte motions for appointment of experts shall be heard or decided by the Hon. Robert C. Olson (RCO), commencing July 1, 2018.

MENTAL HEALTH/ RULE 11

IT IS FURTHER ORDERED that all Mental Health cases (identified by the prefix MH), pursuant to A.R.S § 36-501; and, any criminal cases in which the competency and/or restoration of the defendant is at issue pursuant to Rule 11 of the Arizona Rules of Criminal Procedure, except those matters assigned to the Mental Health/ Veterans Treatment Court established by AO201500057, shall be heard by the Hon. Henry G. Gooday (HGG) commencing April 1, 2018.

FAMILY

IT IS FURTHER ORDERED that commencing April 1, 2018, all new Family Law or Domestic Relations cases (identified by the prefix DO), shall be assigned to the Hon. Delia R. Neal (DRN); the Hon. Kevin D. White; the Hon. Patrick K. Gard; and the Hon. Richard T. Platt (RTP) as determined by the two terminal digits of each Domestic Relations file as follows:

FAMILY LAW COMMISSIONER/IVD

IT IS FURTHER ORDERED that the all new Family Law or Domestic Relations cases (identified by the prefix DO), which proceed to a default hearing; and, any case to establish, enforce or modify child support that the Arizona Attorney General Office is the attorney of record, shall be heard by the Honorable Dwight P. Callahan on a designated "Family Law Commissioner" calendar, commencing July 1, 2018.

GUARDIANSHIP/CONSERVATORSHIP

IT IS FURTHER ORDERED that all Guardianship and/or Conservatorship cases (identified by the prefix GC/CO), filed pursuant to Title 14 of the Arizona Revised Statutes currently being heard by the Hon. Robert C. Olson (RCO) on the designated Guardianship/Conservatorship calendar shall be heard by the Hon. Kevin D. White (KDW) commencing July 1, 2018.

ADOPTIONS

IT IS ORDERED that commencing March 1, 2018, all adoptions filed by a private party shall be assigned to the Hon. Stephen F. McCarville (SFM) and all adoption cases filed by the Arizona Attorney General or Pinal County Attorney Office shall be assigned to the Hon. Brenda E. Oldham (BEO)


JUVENILE DEPENDENCY/DELINQUENCY

IT IS ORDERED that Judge Daniel A. Washburn (DAW) and Judge DeLana A. Fuller (DJF) shall continue to preside over all dependency matters, including pre-protective hearings every Monday and Wednesday. The objective, to the fullest extent possible and practical, is for the assigned Dependency Superior Court Judge to address all issues including pre-protective placement and permanency and thereby achieve the earliest appropriate adjudication of such matters, which is consistent with the best interests of the child.

IT IS FURTHER ORDERED that any open private Severance cases that were previously assigned to the Hon. Meghan Weagant (MW) and not concluded by June 30, 2018, or, filed after that date shall be reassigned to the Hon. Daniel A. Washburn;

IT IS FURTHER ORDERED that all delinquency matters currently assigned to the Hon. Meghan Weagant, and those filed after July 1, 2018, shall be reassigned to the Hon. Kevin D. White (KDW) as the "Juvenile Delinquency Judge" commencing July 1, 2018.
