ADMINISTRATIVE ORDER

NO. 2013 - 00 13

WHEREAS, the Arizona Governor's Office for Children, Youth and Families is funding a research study by Arizona State University (ASU) entitled *Arizona's Juvenile Justice System: Disproportionate Minority Contact Assessment*;

WHEREAS, the Administrative Office of the Courts (AOC) has accepted the proposal for the research study, is providing certain data to ASU, and has entered into a *Research Data Sharing Agreement* with the Administrative Office of the Courts;

WHEREAS, ASU requires records and information from Pinal County Juvenile Court Services for the research study; and

WHEREAS, Rule 19 of Rules of Procedure for the Juvenile Court and Rule 123 of Rules of the Supreme Court provide the Superior Court may order access to the records of the Juvenile Probation Department;

IT IS ORDERED as follows:

1. Subject to the terms of the *Research Data Sharing Agreement* with the Administrative Office of the Courts, Pinal County Juvenile Court Services is authorized to provide records and information from its social files, detention incident reports and data extracted from the Juvenile On-Line Tracking System (JOLTS) for the file numbers listed in Exhibit A to ASU. The records provided include but are not limited to drug/alcohol treatment information and records; psychological, psychiatric, neuropsychological and psycho-educational evaluations, assessments and reports; sex offender risk assessments; outpatient treatment intake reports; polygraphs; school reports and records; and drug/alcohol, family counseling, therapeutic counseling, private counseling and any psychological counseling reports or notes.
2. Pinal County Juvenile Court Services has the right to withhold any record it deems unnecessary or otherwise inappropriate for release to ASU.
3. ASU shall secure all Pinal County Juvenile Court Services records and information and shall not copy or use the records and information for research not authorized by the *Research Data Sharing Agreement*.
4. ASU shall ensure that only ASU employees, researchers, students, interns, externs and/or volunteers who have been approved by Pinal County Juvenile Court Services have access to the records and information provided under this order.

5. The final report shall not include personal identifiers or any information which may be used to identify a specific child.

6. When the report has been completed and the records and information is no longer needed, ASU shall destroy all records and information, and shall confirm to Pinal County Juvenile Court Services Department that the records and information have been destroyed.

IT IS FURTHER ORDERED that ASU shall provide a copy of the final report to the Juvenile Presiding Judge and this Administrative Order terminates upon receipt of the final report to the Juvenile Presiding Judge.
