The Honorable Lyle Riggs, Justice of the Peace, Precinct No. 8 has requested the appointment of Roger Valdez; and

The Honorable Larry Bravo, Justice of the Peace, Precinct No. 6 has requested the appointment of Andrew Ramirez, Robert D. Kent and Luigi "Lou" Digirolamo; and

**WHEREAS** the Presiding Judge finds that the afore-listed requests for appointment is necessary, appropriate and in the best interest of the Judicial Branch of Government in Pinal County;

**NOW, THEREFORE** pursuant to A.R.S. § 22-121(B),

**IT IS HEREBY ORDERED**, that **MARIE "TONI" LORONA, ROGER VALDEZ, ANDREW RAMIREZ, ROBERT D. KENT** and **LUIGI "LOU" DIGIROLAMO** be and they are hereby appointed to serve as Justices of the Peace *Pro Tempore* for a period commencing January 1, 2015 and ending December 31, 2015.

**IT IS FURTHER ORDERED** that **MARIE "TONI" LORONA, ROGER VALDEZ, ANDREW RAMIREZ, ROBERT D. KENT** and **LUIGI "LOU" DIGIROLAMO** be compensated in accordance with state law; payable through funds budgeted in the Judicial Branch and/or the Justices of the Peace for such purposes.

This appointment is at the pleasure and direction of the Presiding Judge of the Superior Court. Such appointment may be terminated without cause at any time by the Presiding Judge.
