Pursuant to the Constitution of the State of Arizona, Art. 6, Sec. 24, A.R.S. §12-213, as amended, and Rule 96 of the Rules of the Arizona Supreme Court (RASC),

**IT IS ORDERED** that Megan K. Weagant is hereby appointed as a Court Commissioner of the Superior Court of Arizona in Pinal County, on a part time basis, commencing January 3, 2017 and ending June 30, 2018, subject to annual reappointment by the Presiding Judge.

**IT IS FURTHER ORDERED** that Megan K. Weagant shall have all such powers and duties pursuant to law which shall include, but not be limited to, those powers and duties prescribed by A.R.S. §12-213, as amended, and Rule 96, RASC, as amended.

**IT IS FURTHER ORDERED** that Megan K. Weagant shall be compensated according to the existing compensation plan for a Commissioner of the Superior Court in Pinal County, and

This appointment is conditioned upon the agreement to serve only for the compensation received as a Court Commissioner while employed as a Commissioner by the Court, and to receive no additional compensation or benefit, fiscal or otherwise, when acting in the capacity of a Judge Pro Tempore.

**IT IS FURTHER ORDERED** that Megan K. Weagant is assigned to hear and decide matters assigned to her by the Presiding Judge, without further written order.

PRO TEMPORE ORDER

The presiding judge of the Superior Court of Arizona in Pinal County has requested the appointment of a court commissioner to serve as a judge pro tempore to assist that court with the processing of cases. Therefore, pursuant to Ariz. Const. Art. VI, § 31 and A.R.S. § 12-141 et seq.,

IT IS ORDERED that Megan K. Weagant, State Bar #027244, is appointed judge pro tempore to serve the Superior Court in Pinal County for a term beginning January 3, 2017, and ending June 30, 2017.

IT IS FURTHER ORDERED that the appointee shall perform judicial duties authorized by A.R.S. § 12-144 as assigned by the presiding judge. This appointment is conditioned upon the approval of the Pinal County Board of Supervisors pursuant to A.R.S. § 12-141, and upon the agreement by the appointee to serve without compensation or benefits, other than that to which she is entitled as Superior Court Commissioner, as provided in A.R.S. § 12-142(C) and A.R.S. § 12-143 for service as judge pro tempore.

IT IS FURTHER ORDERED that the appointee may perform duties of a judge authorized by A.R.S. § 25-121 et seq. and A.R.S. § 12-2222 without specific assignment by the presiding judge and subject to agreement by the appointee to perform these duties without public compensation or benefits.
