**WHEREAS** the Presiding Judge of the Superior Court of Arizona in and for Pinal County is the chief judicial officer of the county and has administrative authority over all the courts in Pinal County, pursuant to Article VI of the Arizona Constitution and Arizona Supreme Court Administrative Order No. 2005-32 (revised May 16, 2005); and,

**WHEREAS** the Honorable Brett Eisele, Justice of the Peace, Precinct No. 1 has requested the appointment of Raquel Garcia; and

**WHEREAS** the Presiding Judge finds that the afore-listed request for appointment is necessary, appropriate and in the best interest of the Judicial Branch of Government in Pinal County;

**NOW, THEREFORE** pursuant to A.R.S. § 22-121(B),

**IT IS HEREBY ORDERED**, that **Raquel Garcia** be and she is hereby appointed to serve as Justice of the Peace *Pro Tempore*, for a period commencing March 8, 2017 and ending December 31, 2017.

**IT IS FURTHER ORDERED** that **Raquel Garcia** be compensated in accordance with state law, payable through funds budgeted in the Judicial Branch and/or the Justices of the Peace for such purposes; and,

While serving in the capacity of Justice of the Peace *Pro Tempore*, Raquel Garcia will suspend her activities as the Judicial Office Manager/Supervisor for the Florence-Coolidge Justice Court. In accordance with Pinal County Human Resources requirement for proper time coding, separate time sheets will be submitted detailing the number of hours worked in each capacity. Use of vacation accruals, working an alternate schedule, or working hours outside of the normal hours of operation for the Court (8:00 a.m. to 5:00 p.m.) will not be permitted as a way to recover time lost in his primary duties.

This appointment is at the pleasure and direction of the Presiding Judge of the Superior Court. Such appointment may be terminated without cause at any time by the Presiding Judge.
