ADMINISTRATIVE ORDER

No. 2017 - 00041

**WHEREAS** the Presiding Judge of the Superior Court of Arizona in and for Pinal County is the Chief judicial officer of the county and has administrative authority over all courts in Pinal County, pursuant to Article VI of the Arizona Constitution and Arizona Supreme Court Administrative Order No. 2017-79; and

**WHEREAS** the Honorable Karl Eppich has been appointed to the Court of Appeals, Division II, which requires the reassignment of his caseload, and modification of the current allocation of resources

**NOW, THEREFORE, IT IS ORDERED** affirming all current duties and assignments of all full-time and part-time judicial officers of the Superior Court, except where modified by this Administrative Order, effective August 1, 2017.

**FAMILY**

**IT IS ORDERED** that Judge Delia R. Neal (DRN) shall continue to be assigned to the Family Bench, and shall be the Presiding Family Law Judge.

**IT IS FURTHER ORDERED** that Judge Pro Tem's Richard T. Platt (RTP) and Patrick K. Gard (PKG) shall be assigned to the Family Bench and shall be directly supervised by the Presiding Family Law Judge, except that the Presiding Judge shall continue to assign temporary court-calendar coverage duties, as required.

**IT IS FURTHER ORDERED** that all new Family Law or Domestic Relations cases (identified by the prefix DO), shall be assigned to the Hon. Delia R. Neal (DRN); Patrick K. Gard; and Richard T. Platt (RTP) as determined by the two terminal digits of each Domestic Relations file as follows:

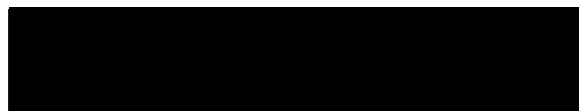

**IT IS FURTHER ORDERED** that all pending domestic relation cases currently assigned to Judge Karl C. Eppich shall be reassigned to Hon. Richard T. Platt (RTP). These matters should be reassigned as soon as practical, by whatever method deemed most appropriate by the Presiding Family Law Judge, but case transfer shall be completed no later than August 31, 2017, and thereafter on a case-by-case basis by the Presiding Family Law Judge.

**CIVIL**

**IT IS FURTHER ORDERED** the Superior Court Judges may delegate the following additional Civil proceedings to Commissioner/JPT Lawrence M. Wharton (LMW): all cases in which the Plaintiff is in custody of the ADOC or other correctional facility or jail; [this authority includes Habeas Corpus and civil rights litigation]. Judge Dwight Callahan shall hear all lower court appeals until further notice. All supplemental proceedings; provisional remedy in replevin; change of name, civil forfeiture, requests related to service of process; and other matters shall be heard by the assigned judge or as directed by Judge Joseph Georgini as Presiding Civil Judge. In any such delegations, the assigned Superior Court's staff shall provide support to Judge Wharton and/or Judge Callahan, consistent with current practice on this caseload.
