ADMINISTRATIVE ORDER  
**AMENDED**  
No. 2018 - 00039

**WHEREAS** the Presiding Judge of the Superior Court of Arizona in and for Pinal County is the Chief judicial officer of the county and has administrative authority over all courts in Pinal County, pursuant to Article VI of the Arizona Constitution and Arizona Supreme Court Administrative Order No. 2017-79; and

**WHEREAS** the Honorable Robert Carter Olson and the Honorable Patrick K. Gard have been appointed to the Pinal County Superior Court bench, modification of the current allocation of resources is necessary;

**NOW, THEREFORE, IT IS ORDERED** affirming all current duties and assignments of all full-time and part-time judicial officers of the Superior Court, except where modified by this Administrative Order, effective November 1, 2018.

**ABORTION**

**IT IS ORDERED** that Judge Daniel A. Washburn (DAW) and Judge Joseph R. Georgini (JRG), or their designee, shall preside over any petitions filed pursuant to A.R.S. §36-2152.

**ADOPTIONS**

**IT IS ORDERED** that commencing March 1, 2018, all adoptions filed by a private party or attorney shall be assigned to the Hon. Stephen F. McCarville (SFM) and all adoption cases filed by the Arizona Attorney General or Pinal County Attorney Office shall be assigned to the Hon. Kevin D. White (KDW).

**CIVIL**

**IT IS FURTHER ORDERED** that all new Civil files (identified by the prefix (CV), regardless of the specific case type, filed on or after November 1, 2018, shall be assigned to the Hon. Steve J. Fuller (SJF), Hon. Robert C. Olson (RCO) and the Hon. Stephen F. McCarville (SFM), as determined by the two terminal digits of each new Civil file, as follows:

**IT IS FURTHER ORDERED** that all pending civil cases currently assigned to Judge Brenda E. Oldham (BEO) shall be reassigned to Hon. Robert C. Olson (RCO).

**IT IS FURTHER ORDERED** all cases in which the Plaintiff is in custody of the ADOC or other correctional facility or jail, including Habeas Corpus and civil rights litigation; and, all lower court appeals shall be assigned to Commissioner/JPT Barbara A. Hazel (BAH).

**IT IS FURTHER ORDERED** the following additional Civil proceedings shall be heard by the assigned judge or as directed by the Presiding Civil Judge: All supplemental proceedings; provisional remedy in replevin, change of name, civil forfeiture, requests related to service of process.

**CRIMINAL**

**IT IS ORDERED** that all new Criminal files (identified by the prefix CR), except for those matters assigned to specialty courts, such as "Early Disposition Court", shall be assigned to the Hon. Jason R. Holmberg (JRH), Hon. Christopher J. O'Neil (CJO), Hon. Delia R. Neal (DRN), and the Hon. Patrick K. Gard (PKG), as periodically determined by separate Order of the Presiding Criminal Judge.

**IT IS FURTHER ORDERED** that all matters assigned to the “Early Disposition Court”; and, “Probation Revocation Court” shall be heard by Judge Lawrence W. Wharton (LWW).

**IT IS FURTHER ORDERED** that the Presiding Criminal Judge shall designate the judicial officer for the arraignment calendar.

**IT IS FURTHER ORDERED** that the Presiding Criminal Judge shall direct the reassignment of capital cases currently assigned to Judge Joseph R. Georgini and Judge Kevin D. White to the Hon. Jason R. Holmberg (JRH), Hon. Christopher J. O’Neil (CJO), Hon. Delia R. Neal (DRN), and the Hon. Patrick K. Gard (PKG), as soon as practical, by whatever method deemed most appropriate by the Presiding Criminal Judge .

**IT IS FURTHER ORDERED** that all of the remaining non-capital criminal cases currently assigned to Judge Joseph R. Georgini (RJG) that were filed on or after July 1, 2018 and are not currently set for trial before January 1, 2019, shall be assigned to Judge Delia R. Neal (DRN), considering potential conflicts. The Presiding Criminal Judge shall also direct the reassignment of the current Criminal cases of Judge Lawrence W. Wharton (LWW), that were filed before July 1, 2018, and are not currently set for trial before January 1, 2019 to Judge Patrick K. Gard (PKG) considering potential conflicts. These matters should be reassigned as soon as practical, by whatever method deemed most appropriate by the Presiding Criminal Judge, but case transfer shall be completed no later than February 1, 2019, and thereafter on a case-by-case basis by the Presiding Criminal Judge.

**IT IS FURTHER ORDERED** that all ex-parte motions for appointment of experts shall be heard or decided by Judge Robert C. Olson (RCO), commencing November 1, 2018.

### **FAMILY**

**IT IS ORDERED** that Judge Joseph R. Georgini (JRG) shall be assigned to the Family Bench and shall be the Presiding Family Law Judge.

**IT IS FURTHER ORDERED** that Judge Pro Tem’s Richard T. Platt (RTP) and Karen F. Palmer (KFP) shall be assigned to the Family Bench and shall be directly supervised by the Presiding Family Law Judge, except that the Presiding Judge shall continue to assign temporary court-calendar coverage duties, as required.

**IT IS FURTHER ORDERED** that all new Family Law or Domestic Relations cases (identified by the prefix DO), shall be assigned to the Hon. Joseph R. Georgini

(JRG); Richard T. Platt (RTP); and, Karen F. Palmer (KFP) as determined by the two terminal digits of each Domestic Relations file as follows:

**IT IS FURTHER ORDERED** that all pending domestic relation cases currently assigned to Judge Delia R. Neal (JRG) shall be reassigned to Hon. Joseph R. Georgini (JRG); and all pending domestic relation cases currently assigned to Judge Dwight P. Callahan (DPC) shall be reassigned to Hon. Karen F. Palmer (KFP). These matters should be reassigned as soon as practical, by whatever method deemed most appropriate by the Presiding Family Law Judge, but case transfer shall be completed no later than January 31, 2019, and thereafter on a case-by-case basis by the Presiding Family Law Judge.

**FAMILY LAW COMMISSIONER/IVD**

**IT IS ORDERED** that the all new Family Law or Domestic Relations cases (identified by the prefix DO), which proceed to a default hearing; all consent decrees; and, any case to establish, enforce or modify child support that the Arizona Attorney General Office is the attorney of record, shall be heard by the Honorable Dwight P. Callahan on a designated "Family Law Commissioner" calendar, commencing November 1, 2018. In addition, all petitions to enforce a decree, child support or spousal maintenance, or, to modify child support shall also be assigned to Judge Callahan, except, in cases in which the judge who issued the order is on a family law assignment, that case shall be heard by that judge.

## **GUARDIANSHIP/CONSERVATORSHIP/PROBATE**

**IT IS ORDERED** that all Guardianship and/or Conservatorship cases (identified by the prefix GC), filed pursuant to Title 14 of the Arizona Revised Statutes currently being heard by the Hon. Robert C. Olson (RCO) on the designated Guardianship/Conservatorship calendar shall be heard by the Hon. Kevin D. White (KDW) commencing November 1, 2018.

**IT IS FURTHER ORDERED** that all Probate cases (identified by the prefix (PB), filed pursuant to Title 14 of the Arizona Revised Statutes shall also be heard by the Hon. Kevin D. White (KDW) on the designated Probate calendar commencing November 1, 2018.

## **JUVENILE DEPENDENCY/DELINQUENCY**

**IT IS ORDERED** that Judge Daniel A. Washburn (DAW) and Judge DeLana A. Fuller (DJF) shall continue to preside over all dependency matters, including pre-protective hearings every Monday and Wednesday. The objective, to the fullest extent possible and practical, is for the assigned Dependency Superior Court Judge to address all issues including pre-protective placement and permanency and thereby achieve the earliest appropriate adjudication of such matters, which is consistent with the best interests of the child.

**IT IS FURTHER ORDERED** that any open private Severance cases that were previously assigned to the Hon. Meghan Weagant (MW) or Judge Kevin D. White that are not concluded by November 30, 2018, shall be reassigned to the Hon. Barbara A. Hazel (BAH). All new cases filed on or after November 1, 2018, shall be assigned to Judge Barbara A. Hazel. (BAH)

**IT IS FURTHER ORDERED** that all delinquency matters shall be assigned to the "Juvenile Delinquency Judge" commencing July 1, 2018 and shall be heard by Hon. Kevin D. White (KDW).

## **MENTAL HEALTH/ RULE 11**

**IT IS FURTHER ORDERED** that all Mental Health cases (identified by the prefix MH), pursuant to A.R.S § 36-501; and, any criminal cases in which the competency and/or restoration of the defendant is at issue pursuant to Rule 11 of the Arizona Rules of Criminal Procedure, except those matters assigned to the Mental Health/ Veterans Treatment Court established by AO201500057, shall be heard by the Hon. Lawrence W. Wharton (LWW) commencing November 1, 2018.

## **SPECIALTY COURTS**

**IT IS ORDERED** that all specialty courts, (except “Early Disposition Court” and Probation Revocation Court”) such as “Drug Court”; “Mental Health Court” “; Domestic Violence Court”; “Restitution Court” and, “Veteran’s Court” shall be heard by Judge Barbara A. Hazel.

## **DESIGNATION OF PRESIDING JUDGES**

**IT IS ORDERED** delegating the authority of the Presiding Judge to the following jurists as presiding judges of their respective benches:

Hon. Jason H. Holmberg, Criminal Presiding Judge  
Hon. Stephen F. McCarville, Civil Presiding Judge  
Hon. Daniel Washburn, Juvenile Presiding Judge  
Hon. Joseph R. Georgini, Family Law Presiding Judge

**IT IS FURTHER ORDERED** that the Presiding Judge for each bench is delegated general authority over their bench, except as modified or limited by Administrative Order or direction by the Presiding Judge, and shall specifically supervise staff judges that are assigned to the bench, coordinate coverage, reassign cases within the bench as required, and provide a monthly assignment report to the Presiding Judge.

## **SUPPORT STAFF FOR COMMISSIONERS/PRO TEMS**

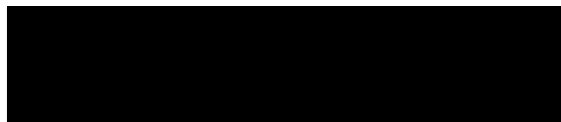
The Superior Court has a serious shortage of support staff, which is not expected to change in the foreseeable future. For this reason, assigned Superior Court Judges shall continue to provide staff support, as needed, when their cases are heard by Commissioners/JPT. In all other circumstances, the Presiding Judge shall allocate the limited support staff that reports to the Presiding Judge.

**IT IS FURTHER ORDERED** that the regularly assigned Commissioners/JPT shall be assigned the following Division numbers:
