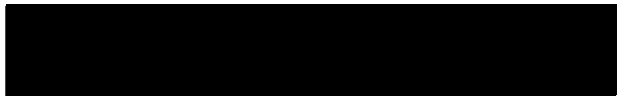
NOW, THEREFORE pursuant to A.R.S. § 22-506 and 28-1553,
