WHEREAS the Presiding Judge of the Superior Court of Arizona in and for Pinal County is the Chief Judicial Executive Officer of the County and has administrative supervision over all courts in Pinal County pursuant to Article VI of the Arizona Constitution and Arizona Supreme Court Administrative Order No. 2017-79; and

WHEREAS the Presiding Judge has determined the need to update the court's policies with regards to the establishment of a schedule of fees for transcripts produced by court reporters employed by the Pinal County Superior Court.

THEREFORE, IT IS ORDERED rescinding Administrative Order 2005-0036; in its Entirety and that a schedule of fees for transcripts are established as follows:

I. Designation of the Official Record

When an Arizona-certified court reporter records a proceeding in the Pinal County Superior Court that is simultaneously recorded by electronic recording equipment, the court reporter's record shall be the official record. When no certified court reporter is present in a court proceeding, the electronic recording shall be the official record. Official transcripts of court proceedings prepared from electronic recordings shall comply with the Arizona Manual of Transcript Procedures. No transcripts of the proceedings of the Court shall be considered as an official record except those records prepared by a certified court reporter.

II. Requests for Records of Court Proceedings

If a party is seeking a record of proceedings held in the Pinal County Superior Court where a court reporter was present, that party shall contact the Court Reporter who recorded the proceedings or the Court Reporter's supervisor to request a transcript. If a party is seeking a record of proceedings held in the Pinal County Superior Court where a court reporter was not present, that party shall submit the request to Court Administration.

III. Payment for Transcripts

Payment for transcripts of court proceedings when the case is on appeal to an Arizona appellate court is authorized by A.R.S. Section 12-224. Payment for transcripts of Grand Jury Proceedings is set by Administrative Order No. 2007-0007. The different categories of requests, other than those set by statute or rule, are as follows:

- Standard = delivery of the transcript in 3 to 4 weeks following date of order.
- Expedited = delivery of the transcript within 7 business days from date ordered.
- Overnight/Daily = delivery of the transcript by 9:00 a.m. the next business day after ordered.

Guidelines for the payment of transcripts in all court proceedings are set forth by the following charts:

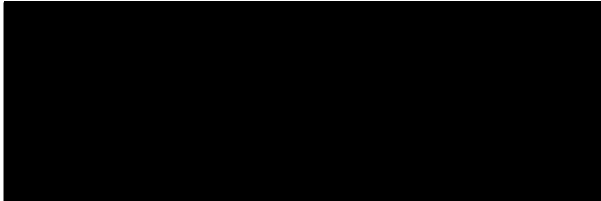
