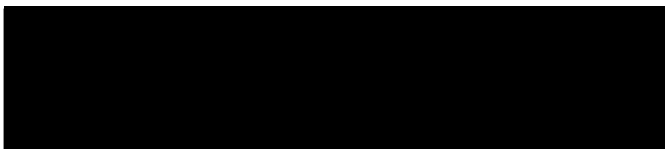

In addition, adopting best practices and implementing innovative approaches that improve efficiency and the sharing of information among stakeholders contributes to a better court system.

IT IS ORDERED that the Subcommittee on Pretrial Case Processing be created to meet these needs and the individuals listed in Appendix A are appointed as members of the Subcommittee on Pretrial Case Processing. The Presiding Judge may appoint additional members as may be necessary.

The Subcommittee shall meet as necessary and at the discretion of the Subcommittee Chair. Court Administration shall provide staff to assist and support the Subcommittee.
