WHEREAS, the Presiding Judge of the Superior Court of Arizona in and for Pinal County is the chief judicial officer of the county and has administrative authority over all courts in Pinal County, pursuant to Article VI of the Arizona Constitution and Arizona Supreme Court Administrative Order No. 2017-79; and

WHEREAS, this is an election year and election contests must be resolved in an expedited manner and therefore shall take precedence on court calendars.


IT IS HEREBY ORDERED that the Honorable Lacey S. Gard (LSG), Patrick K. Gard (PKG), Joseph R. Georgini (JRG), Jason R. Holmberg (JRH), Robert C. Olson (RCO) and Christopher J. O'Neil (CJO) are appointed as Election Judges for a term of one (1) year. Election Judges shall preside over all cases brought in Pinal County dealing with any type of election issue.

These appointments are at the pleasure and direction of the Presiding Judge of the Superior Court and may be terminated, without cause, at any time.

IT IS FURTHER ORDERED that election cases will be assigned a civil case number and forwarded to the Presiding Judge. To the extent possible, the Presiding Judge will balance assignments and use the below matrix as a guide:
