**WHEREAS**, the Presiding Judge of the Superior Court of Arizona in and for Pinal County is the chief judicial officer of the county and has administrative authority over all courts in Pinal County, pursuant to Article VI of the Arizona Constitution and Arizona Supreme Court Administrative Order No. 2017-79; and

**WHEREAS**, a transfer of cases and modification of the current scheduling matrix is necessary due to the retirement of the Honorable Barbara R. Hazel;

**IT IS HEREBY ORDERED** that all juvenile dependency and severance cases currently assigned to Barbara A. Hazel (BAH) be reassigned to Jamie R. Ramirez (JRR), no later than October 31, 2022.

**IT IS HEREBY ORDERED** that Jamie R. Ramirez be assigned Division number 119.

**IT IS FURTHER ORDERED** that all Severance matters filed by the Arizona Attorney General, and/or arising from a Dependency matter, shall continue to be heard by the assigned dependency judge. All new private severances (identified by the prefix (SV), filed on or after October 5, 2022, shall be assigned to Delia R. Neal; Jamie R. Ramirez and Jessica Kristine-Hernandez Dixon, as determined by the two terminal digits of each new Severance file, as follows:
