
**NOW, THEREFORE** pursuant to A.R.S. § 22-506 and 28-1553,

**IT IS HEREBY ORDERED** that the aforementioned Civil Traffic Hearing Officers and Small Claims Hearing Officers reappointed, upon the same terms and conditions of their original appointment but said reappointment shall be for a period commencing January 1, 2023 and ending December 31, 2023.
